D. ACHIEVEMENTS AND SUCCESSES**1. Summarize your most innovative achievement or your greatest success story from the previous year.**

An ambitious slate of health IT curriculum development was successfully completed in Year 1. Due to rapid Consortium start, certificate programs such as Mobile Device Management in Healthcare; Healthcare Data Analytics and Health IT Security were developed using Consortium approval standards; pilots are underway. Challenge exams to provide credit for prior learning were created concurrently an ideal, but seldom possible development scenario, due to lack of resources. Bellevue College was selected by Carnegie Mellons Open Learning Initiative for its highest level of TAACCCT assistance. Resulting co-development, although unexpectedly labor intensive, is producing high value outcomes.
